RETURN MATERIAL: When orders have been filled as specified, goods may be returned by purchaser once Dunn Electric authorization has been obtained. Dunn Electric's standard policy, subject to change without notice, is to accept returned material and issue store credit on authorized materials for purchasers providing a receipt on stock merchandise. There are no returns on cut-wire. Returns on special orders are subject to terms and conditions of manufacturer's policy.

<u>MANUFACTURER'S WARRANTY</u>: Materials sold by Dunn that are covered by a manufacturer's warranty are covered only to the extent of such warranty. These manufacturer's warranties, which are given in lieu of all other warranties, expressed or implied, of merchantability and fitness for particular purpose, constitutes the only warranty made by Dunn Electric.

<u>TRUST FUNDS & JOB BILLING</u>: Dunn Electric policy is to rely upon the trust fund provisions of Federal and State laws requiring that contractors receiving payments on a job use such funds to pay their suppliers. When asked, purchaser is expected to provide complete job names and addresses for material purchased.

<u>SERVICE CHARGES:</u> A Service charge of 1.5% percent per month (18% per annum) will be billed to your account on all invoices over 30 days past due. This service charge is subject to change based on market conditions, with adequate notification being made to creditor.

<u>TERMS OF PAYMENT:</u> Terms are 1% 10 days, net 30. Dunn Electric reserves the right to demand payment in full with all accrued service charges at any time after the first service charge has been made. Purchaser agrees to pay Dunn Electric reasonable collection fees in the event the account is placed in the hands of an agent for collection, and/or reasonable costs incurred by Dunn Electric for self-representation of collection efforts.
